Consolidated Rent-A-Car Center (ConRAC)

- We're out of the ground!
- All footings have been placed for the Ready Return Garage and Customer Service Building.
- Level 2 Garage is in process.
- Erection of steel structure for Customer Service Building has begun.





Electric Boiler Addition




- Start-up of new electric boiler happened on Oct. 22nd and will serve as the terminal's primary boiler.
- This project supports the city's clean electricity goals.
- Project was partially funded by BIL ATP grant funds.



Taxiway D Relocation & ARFF Access Road Construction

 Substantial completion is expected to be issued on November 15.





Taxi Lane N North Extension

- Construction is underway. Targeting completion in mid-November.
- Taxi Lane construction will allow for future GA Hangers to access the airfield.





Concourse Development and Terminal Improvements

- Fentress, the program architect, continues to work on:
 - Developing the commercial forecast to develop programming needs for the facility and complete a Gap Analysis.
 - Modeling existing conditions.
- Owner's Representative, Jacobs Project Management:
 - Goal is to augment Airport staff to help manage and execute projects.
- Construction Manager General Contractor (CM/GC):
 - Expecting to issue this RFQ in early 2025.





Concessions Revamp Update




- Delaware North and Paradies Lagardère are currently finalizing their project designs.
- Projects are at 30% design review, with construction expected to start around the end of the year.
- A Concessions Open House is scheduled for Wednesday, December 4th at 10am to showcase the new vendors and treat media and passengers to product sampling.



Master Plan Update

- The current Master Plan was adopted in 2019.
- A Request for Qualifications is out for advertisement now to update the Master Plan. Statement of Qualifications are due November 13 at 3pm MT.
- The master plan update will be comprehensive of all components and facilities on the airside and landside.






Concourse A: BIL-ATP Grant Awarded

\$9 Million Grant Awarded to Purchase Passenger Boarding Bridges

BOI was awarded \$9M in grant funding to put towards the construction of Concourse A, including the procurement of long-lead time items like the eight passenger boarding bridges and their associated ground power units and pre-conditioned air units.

Cell Phone Waiting Area



Say goodbye to congestion. This is a real parking lot, three times larger than the previous area.

- The cell phone waiting area was relocated to a new, dedicated parking lot on October 15.
- Adjacent to the Economy Lot. Only a 5–7-minute drive from the terminal.
- Opening received media coverage on all major stations.



Fitch Affirms Airport Rating

- Fitch Ratings has affirmed the 'A+' rating on Boise City, ID's \$55.3 million senior lien airport revenue bonds and the 'A' rating on \$9.7 million subordinate lien airport revenue bonds.
- The Rating Outlook is Stable.
- Rating does not include the 2024 CFCbacked bonds for the ConRAC, which are rated separately.

Backcountry Operations For Next Season

- Air Taxi/Backcountry operators have used Gate 58 for their operations. This gate is located in a future construction area for the Concourse A apron.
- These users have been notified that they will no longer have access to the ramp by Gate 58 for parking after the 2024 season and will need to make alternative arrangements.






A Successful NWAAAE Conference


- Buy Idaho held its 38th annual reception to celebrate its members and the outstanding accomplishments of Idaho's small business community.

September Enplanements


Up 4% from September 2023



Boise Traffic/Capacity Trends




YE June 2024 capacity and passengers were up 2% and the average load factor increased one point (84%).




Seats Per Capita Comparison
