Concessions Update

- Temporary walls are in place at active worksites.
- Substantial completion expected:
 - Boise Depot mid-April
 - Sawtooth Essentials mid-April
 - Treefort end of July
- Awaiting permits
 - Blue Sky Bagels, Pizza Hut, Protein Bar
 - Waffle Me Up/The STIL



Concourse B Family Restroom Project

- Floor and wall tile work is 90% complete.
- After tile work is finished, dry wall, paint, accessories and trim will be completed.
- Substantial completion scheduled for mid-April.
- Located next to Gate B16.





Consolidated Rent-A-Car Center (ConRAC)

- Level 5 of the ready return garage is complete – 2 levels left to go!
- Steel structure for terminal connector is underway.
- Interior and exterior framing has started at the customer service building.



Concourse Development and Terminal Improvements Program Update

- Fentress, the program architect:
 - Working with Aero (a subconsultant) on Passenger Boarding Bridge (PBB) bid package to be released this week
 - Initial steps for Concourse A Visioning in April
- Jacobs Project Management, Owner's Representative:
 - Concourse A: PBB support, schedule and budget support
 - Collaborating on CM/GC RFQ and interview process
- Construction Manager General Contractor (CM/GC):
 - RFQ released on January 31
 - Received seven SOQ responses on March 12
 - Short-listed four firms for interviews in May




East De-Ice Apron Expansion

- Bids opened March 19; Idaho Materials and Construction was selected.
- Contract expected to be sent to City Council on April 8th.
- Construction start date to be established after contract approval.
- Project will provide a larger area for planes to de-ice.




Concourse A Apron



- Bids opened March 5; Idaho Materials and Construction was selected.
- Contract was approved by City Council on March 25.
- Construction scheduled to start April 14.

Master Plan Update

- InterVISTAS scope of work submitted to FAA for approval.
- Work will begin following FAA concurrence.
- The Master Plan update will be comprehensive of all components and facilities on the airside and landside.
- The current Master Plan was adopted in 2019.



Boise Airport: 99th Anniversary!

- April 6, 1926: The first commercial airmail flight in the United States passed through BOI, which was located on what is now Boise State University.
- It was operated by Varney Airlines, which would later become United Airlines.
- United began passenger service from Boise four years later.

Aircraft Incidents

- Last week, two minor incidents involving commercial aircraft were reported at BOI.
- A United Airlines flight diverted to Boise due to a mechanical issue.
 All 133 passengers and crew exited the plane after a safe landing.



- An Alaska Airlines flight landed safely but its brakes locked, and it was unable to taxi to a gate. Shuttles from The Car Park were used to bring 76 passengers and four crew to the terminal.
- Thank you to The Car Park for their quick assistance! VRT was also notified, ready to enact the newly established SOP agreement with the airport.

ConRAC: Call for Artists

- The Artist Call for Qualifications was issued by the Arts & History Department on April 1st.
- The selected artist will create two designs: a large banner for the east façade and a series of vinyl panels for the connecting walkway.
- Finalists expected to be announced in May 2025 with the final artist selected later this summer.

FAA Part 139 Inspection

- The Boise Airport will undergo the FAA's annual inspection that ensures we are meeting the requirements of Part 139 Airport Certification later this month

- Certification inspections include the following steps:
 - Pre-inspection review
 - In-briefing with airport management
 - Administrative inspection of airport files, paperwork
 - Movement area inspection

- Aircraft rescue and fire fighting inspection
- Fueling facilities inspection
- Night inspection
- Post inspection briefing

- Local media helped share the message for passengers to arrive early.
- Airport parking was near capacity, but didn't overfill.
- Alaska Airlines seasonal non-stop service to Orlando has ended.

Hidden Disabilities Sunflower Program



- BOI is the first site in a City of Boise pilot project to introduce the Hidden Disabilities Sunflower Program.
- The program supports people living with non-visible disabilities.
- Airport staff will be trained to assist people wearing the distinctive lanyards.
- Program will officially launch for the public Mid-April.
- Sunflower Lanyards are free.




2025 YTD Total Passengers (through February)
